CITY COUNCIL HIGHLIGHTS

December 2, 2014

RESOLUTION CERTIFYING THE NOVEMBER 4, 2014 ELECTION (Agenda Item No. 4)

The City Council adopted a Resolution certifying the results of the general municipal election held on Tuesday, November 4. The results reelected Council Member Scott Voigts and added Council Members Jim Gardner and Andrew Hamilton to the City Council. Also approved by the voters was Ballot Measure X, establishing term limits for Council Members consisting of three four-year terms before having to step down for one two-year election cycle before running for office again. Measure X is effective immediately.

SELECTION OF MAYOR AND MAYOR PRO TEM FOR THE ENSUING YEAR (Agenda Item No. 7)

Council Member Scott Voigts was selected Mayor and Council Member Andrew Hamilton was selected Mayor Pro Tem for the 2015 calendar year.

ADOPTION OF ORDINANCE NO. 269 - ESTABLISHING AN ADMINISTRATIVE CITATION PROGRAM (Agenda Item No. 12)

The City Council voted to approve an Ordinance which establishes an administrative citation program - an additional tool to assist the City in obtaining code enforcement compliance from property owners without having to initiate costly legal actions. After initial requests to abate the code enforcement violations, the City may issue official citations to property owners that fail to correct the violations in order to comply with the City's municipal codes.

NOTICE OF COMPLETION FOR THE LAKE FOREST SPORTS PARK AND RECREATION CENTER PROJECT (Agenda Item No. 13)

The City Council approved the Lake Forest Sports Park by adopting the Notice of Completion. Located on 86 acres at the intersection of Rancho Parkway and Portola Parkway, the Lake Forest Sports Park is the premier City sports facility in South Orange County, containing two full-scale artificial turf soccer/lacrosse fields, six baseball diamonds, one dedicated girls softball diamond, four natural turf soccer fields, a hiking/exercise trail, two concession/restroom buildings, three "tot-lot" playgrounds, and the 35,000 square foot

Recreation Center. The Recreation Center contains a regulation basketball court, dance room, computer lab, teen lounge, several classroom facilities, and a commercial catering kitchen. The total cost of the Lake Forest Sports Park and Recreation Center was \$34,617,691.

PRESENTATION OF TURNING RED TAPE INTO RED CARPET AWARD FROM THE ORANGE COUNTY BUSINESS COUNCIL FOR THE CITY'S G.R.O.W. (GROWING AND RETAINING OUR WORKFORCE) PROGRAM (Agenda Item No. 6.)

The City Council was presented the "Turning Red Tape into Red Carpet" award from the Orange County Business Council for its Growing and Retaining Our Workforce (G.R.OW.) program. The program offers Lake Forest businesses access to no-cost hiring solutions, candidate screenings, on-site recruitments, job fairs, and customized training for employees. G.R.O.W. also facilitates the City's efforts to attract and retain businesses and expands the City's employment base.

PUBLIC HEARING TO CONSIDER STREET NAMES FOR PHASE 2 OF THE SHEA/BAKER RANCH (Agenda Item No. 18)

The City Council approved proposed street names for Phase 2 of the Baker Ranch master planned community. Phase 2 of the Baker Ranch community is currently in the grading stages during which future streets are constructed. The list of names considered by the Council are thematic to Southern California and pertain to native birds, butterflies, flowers, plants and types of oranges.

2015 LEGISLATIVE PLATFORM (Agenda Item No. 19)

The City Council adopted the 2015 Legislative Platform which encompasses their general philosophies regarding statewide issues, such as taxation, local control, zoning regulations, prevailing wage regulations, pension reform, and the state budget process. The Legislative Platform provides the foundation of the City's legislative advocacy efforts for the upcoming State legislative session, and also provides staff with policy guidelines in the event it is necessary for the City to respond to a legislative proposal in a timeframe that does not allow the City Council to take formal action.
