Marcia Rudolph, Lake Forest resident and Orange County Vector Control representative spoke regarding various vector issues.

Jim Gardner, Lake Forest resident, spoke and submitted written materials regarding the ratio of city attorney expenses to operating budget. He also invited the audience to the Lake One Garden Club's plant sale on Saturday May 11th.

Mike Balsamo, representing the Orange County Chapter of Building Industry Association introduced himself as their new Chief Executive Officer.

ACTION: The City Council approved the reading, by title only, of all Ordinances and Resolutions. Said Ordinances and Resolutions which appear on the public agenda shall be determined to have been read by title and further reading waived.

*8. MINUTES OF THE JOINT BUDGET WORKSHOP HELD ON MARCH 26, 2013 AND THE REGULAR MEETING OF THE CITY COUNCIL HELD ON APRIL 2, 2013 submitted by City Clerk.

ACTION: The City Council approved the Minutes as submitted.

*9. RELEASE OF BONDS FOR TRACT NO. 16224 - SHEA BAKER RANCH submitted by Director of Public Works/City Engineer.

ACTION: The City Council: 1. Approved the First Amendment to the agreement for Traffic Signal Maintenance and Operation with the County of Orange, substantially in the form attached. 2. Authorized the Mayor to sign, and the City Clerk to attest and transmit, the First Amendment to the County of Orange for final approval.

*11. FISCAL YEAR 2013/2014 ACTION PLAN FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) submitted by Assistant City Manager.

ACTION: The City Council: approved the Fiscal Year 2013/2014 Action Plan for the City's Community Development Block Grant (CDBG) and authorized its submission to the U.S. Department of Housing and Urban Development (HUD).

DISCUSSION/ACTION ITEMS:

12. FIVE-YEAR STRATEGIC PLAN REVIEW submitted by City Manager.

City Manager Dunek provided a brief staff report and requested staff continue the item in the absence of Mayor Voigts.

Jim Gardner, Lake Forest resident, suggested with new council members they might consider creating a new strategic plan. He also suggested the city use outside sources for the creation of the development plan rather than using staff.

MOTION: On motion by Council Member Herzog and second by Council Member Robinson, the City Council directed staff to continue the item to this item to the May 14, 2013 Budget Workshop meeting. MOTION CARRIED with Mayor Voigts absent.

13. POTENTIAL MODIFICATIONS TO THE CITY'S TEMPORARY SIGNAGE AND PROMOTION PROCEDURES AND LIVE ENTERTAINMENT REGULATIONS submitted by Assistant City Manager and Director of Development Services.

City Manager Dunek recommended staff continue this item in the absence of Mayor Voigts.

MOTION: On motion by Council Member Herzog and second by Council Member Robinson, the City Council continued this agenda item to the May 21, 2013 City Council meeting. MOTION CARRIED with Mayor Voigts absent.

14. LEGISLATIVE AND REGULATORY MATTERS submitted by City Manager.

City Manager Dunek introduced the report dated May 7, 2013.

Council Member Herzog addressed the State's attempt to remove cities rights to regulate their own land use in State Assembly Bill 667 and recommended opposing it. He suggested the City direct its legislative advocate to search all bills for language that makes local land use a statewide concern and the removal of local land use control.

MOTION: On motion by Council Member Herzog and second by Council Member Robinson, the City Council opposed State Assembly Bill 667. MOTION CARRIED with Mayor Voigts absent.

15. REQUEST FOR APPOINTMENT - LEAGUE OF CALIFORNIA CITIES, ASSOCIATION OF CALIFORNIA CITIES, ORANGE COUNTY AND/OR THE ORANGE COUNTY CITY SELECTION COMMITTEE submitted by City Clerk.

Mayor Pro Tem McCullough stated she was applying for the End Homelessness 2020 Housing Commission.

Council Member Herzog noted he is serving as Board Member of the Local Agency Formation Commission for an additional term.

ACTION: The City Council made no appointments.

CITY MANAGER'S REPORT:

City Manager Dunek presented no comments.

CITY COUNCIL COMMENTS:

Council Member Herzog noting it was Public Work's week, commented on the public works innovation of Etnies Skatepark; a collaborative effort with land donated by Bank of America, and a business partnership to develop the site with Etnies and the City of Lake Forest. He also mentioned the City's Economic Development team received an award

from Cal Association of Local Econ Development for outstanding work with local brokers.

Council Member Nick thanked staff and the public for attending the council meeting.

Council Member Robinson commended all of the volunteers in the city and reported attending the Foothill Ranch Community Foundation event which raised money for school technology, the Jim Sax Award luncheon, the Girl Scouts Gold and Silver Awards event, the Boy Scouts Eagle Award Scouting event, and the Rancho Fiesta days at Heritage Hill Historic Park.

Mayor Pro Tem McCullough on behalf of the City of Lake Forest received the Lifetime Achievement Award from Heritage Hill Historic Park, reported attending the Transportation Corridor Agency meeting, the League of California Cities, Orange County quarterly meeting, the Orange County 2020 Ending Homelessness Board meeting, the Orange County Special Needs in Transit Advisory Committee, the Mental Health Services Act Steering Committee, the Girl's Scouts Gold and Silver Awards event, the Boy Scout's Eagle Award Scouting event, met with Fire Authority executives, attended the City of Lake Forest 4th of July parade committee, and wished all a Happy Mother's Day.

Mayor Voigts was absent.

CONTINUED CLOSED SESSION:

There was no continued Closed Session.
